The Stewards, having received a verbal report and photographs from the FIA Technical Delegate, summoned and heard the team manager Mr. Santiago Navarro drivers Mr. AHMED ALKUWARI and Mr. MANUEL LUCCHESI have considered the following matter and determine the following:

## **Facts:**

The car stopped on the road section after SS 2 between 14:12 h and 14:28 h beside the road. The photos submitted show that a person on the left rear of vehicle #218. This situation was also observed by the FIA TD and his two assistants.

## **Offence:**

Breach of FIA CC General Prescription Art. 30.4 and Supplementary Regulations Art. 10.3

## **Decision:**

- **Fine of 500 €**
- **Time penalty of 1 hour**

## **Reason:**

The co-driver explained that the belt was broken, and he and the driver were about to repair the vehicle. Because they stopped, many people arrived and watched them repairing the car. At first the drivers claimed that they did not know any of the persons around them. Nobody helped them to repair the car. The FIA TD stated that a person was working on the car and this person was from the team. The Team manager admitted, that person in question was from the team of car #213.

In FIA CCGP Art. 3.12 is clearly stated that the physical presence of a person or persons in the vicinity of a competing vehicle is been considered as Service. According FIA CCGP Art. 30.4 not Service is allowed on the road section also according the Supplementary Regulation Art. 10.3 outside the service park, it is not permitted to have service.

This Stewards decision was made based on ISC Art. 11.9.3.f; ISC Art. 12.2.1 and Art. 12.2.2; ISC Art. 12.3.1.b and 12.3.1.g

The Competitor is reminded of his right to appeal which is stipulated in the 2019 FIA International Sporting Code and in the 2019 FIA Judicial and Disciplinary Rules.


