The Stewards, having received a report from the FIA Technical Delegate, stating that car Nr 216 has not FIA Passport stickers on the car, after having heard the Crew affected, have considered the following matter and determine the following:

**Crew of Car Nr 216: MUBARAK AL-HAJRI / LAURENT LICHTLEUCHTER**

**Competitor: QMMF TEAM**

**Time: 22/02/2020 at Scrutineering.**

**Fact: Missing the FIA Passport stickers on the car.**

**Offence: Breach of articles 2.12 and 8.3 of 2020 FIA CCR Sporting Regulations and article 283 of Appendix J of ISC.**

**Decision: TO IMPOSE A FINE OF 520 EUROS**

**Fines: In accordance with article 12.7 of the 2020 International Sporting Code, the payment of the fines must be done online, within 48 hours, at the following address:**

**Any delay in making payment may entail Suspension during the period a fine remains unpaid.**

**Reason:** Having considered the matter and the above mentioned article 8.3 of the Sporting Regulations that states that: “ .... the markings linked to the technical passport must not be removed under any circumstances..... ” the Stewards determined that the car presented to scrutineering were in Breach of Article 8.3 of 2020 FIA CCR SR and article 283.8.1 of Appendix J of ISC, and that states that: “ ..... cage which is homologated by an ASN must be identified by means of an identification plate affixed to it..... ”

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
