The Stewards, having received a verbal report from the FIA Technical Delegate, communicating that Car Nr 202 arrived at the end of SS6 with only one spare wheel in the car.

The Stewards summoned and heard the competitor of Car Nr 202, have considered the following matter and determine the following:

### Facts:

The car stopped at the finish of SS6. In the 2 spare wheel racks only one spare wheel was fixed. This situation was observed by the FIA Technical Delegate.

### Offence:

Breach of article 283.18 of Appendix J 2020 and articles 51.4.1 and 51.4.2. of FIA CCR Sporting Regulations 2020.

**Decision:** Time penalty of 10 minutes to be added to their time in SS6.

### Reason:

The team representative explained that the car had a puncture and the crew left the spare wheel in the selective section.

In FIA Appendix J Art. 283.18 it is clearly stated that “*Each vehicle must include at least two spare wheels, ... secured throughout the entire duration of the competition. ...*”


In FIA 2020CCR SR Art 51.4.1 it is clearly stated that “*Any wheel/ tyre ... must reach the next service park...*”

In FIA 2020 CCR SR Art 51.4.2 it is clearly stated that “*No wheel/tyre and/or part may be ...taken off the vehicle elsewhere ...*”.

This Stewards decision was made based on Articles 11.9.3.f; 12.2.1; 12.2.2 and 12.3.1.h of International Sporting Code.

Competitors are reminded that they have the right to appeal in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
